

Jurisdiction Bar Exam Chart

In order to be licensed in a particular jurisdiction, you must take the relevant bar exam identified for the bar exam cycle when you'll be sitting for the bar. In the chart below you will find those that currently utilize the Uniform Bar Exam (UBE) and those that have made the decision to adopt the NextGen Uniform Bar Exam (NextGen UBE). If a jurisdiction is not utilizing the UBE or NextGen UBE, they administer a state-specific bar exam.

Note: Each jurisdiction may also require applicants to complete a state-specific component in addition to the UBE or NextGen UBE, along with other requirements for licensure. Check with the jurisdiction(s) you are interested in obtaining licensure in for the most up-to-date and complete information.
